HERITAGE STOCK HORSE ASSESSMENT

A **HERITAGE STOCK HORSE** is a Registered Australian Stock Horse that has descended from the same breeds as horses ridden by the Australian Light Horse in WWI that resided in Australia prior to 1945. From 1st June 2019, a **HERITAGE STOCK HORSE (HSH)** – is a Stud Book Australian Stock Horse and a **STOCK HORSE (SH)** – is a Special Merit, Exceptional Horses, First and Second Cross Australian Stock Horse. The breed criteria for Heritage Stock Horse and Stock Horse is defined in the Society's Regulations and eligible horses must satisfy all requirements.

Any member may apply to have a Registered ASH assessed by submitting an Application for Heritage Stock Horse Assessment together with the prescribed fee. The assessment will include all Registered Australian Stock Horse ancestors within three generations.

Members are alerted to changes to eligibility criteria for Heritage Stock Horses which will be effective from 1st June 2019. As a result of these changes, it may be that horses that were previously eligible for registration in the Heritage Stock Horse category may not be eligible after the introduction of the new rules. Members are invited to make application to the Society prior to 1st June 2019 to undertake the assessment, at the cost of the applicant.

Once assessed, Registered Australian Stock Horses will be identified through a horse name suffix as follows:

HSH	Heritage Stock Horse	ABP	100% Approved Breeds (existing in Australia before 1945)
SH	Stock Horse (from 1 st June 2019)	AB	50-100% Approved Breeds (existing in Australia before 1945)
TB	100% Thoroughbred	UBP	100% Unknown Breeding (foaled after 1960)
MBP	100% Modern Breeds (introduced to Australia after 1945)	UB	50-100% Unknown Breeding (foaled after 1960)
MB	50-100% Modern Breeds (introduced to Australia after 1945)	LH	Limited Heritage (not eligible under any other code)

Prior to submitting an application, we recommend that you review the horse's details on the Online Stud Book to check that the horse has not been previously assessed. To submit an **Application for HSH Assessment**, please complete the details below and forward it to the Society with payment of fees.
