DNA Parentage – submit registration with fees. DNA kit with instructions will be forwarded.

- ❖ Optional for Natural Service progeny
- ❖ Compulsory for ALL Base Registry horses and Breeding Purposes colts/stallions).
- ❖ Compulsory for Artificial Insemination and Embryo Transfer progeny, plus ALL Base Registry horses and Breeding Purposes colts/stallions.

Note: Compulsory DNA testing for natural service is being worked through a consultative process and general review. Further details will be released when available. Members are advised, compulsory DNA testing may become a requirement at any time (for any registration type) from 1st January 2024 and requirements will be announced in due course.

Genetic Disorder Testing– submit registration with fees. DNA kit with instructions will be forwarded.

- ❖ 6 panel GDT - OLWS, HYPP, HERDA, PSSM1, MH, GBED - compulsory for Sire Registration and Base Registry colts/stallions (or optional).
- ❖ 1 panel GDT - HERDA – Compulsory for Base Registry mares, Optional for other registration types.

Note: Compulsory Genetic Disorder Testing is being reviewed. Further details will be released when available and the above rules may change. Members are advised, compulsory Genetic Disorder Testing may become a requirement at any time (for any registration type) from 1st January 2024 and requirements will be announced in due course.
