LEASE NOTIFICATION DETAILS - The lease of a horse shall be effected only upon the Lease Notification Form being completed by the Owner/Lessor and Lessee at the time of Lease. The Lease Notification Form and the Certificate of Registration or Foal Recording Certificate must be sent directly to the Society. The Lease fee must accompany the Notification.

If the Certificate of Registration is not returned, the Lessee (commencement) or Lessor (termination) will be responsible for a reissue fee.

Important Notice: The Society recommends that the Owner/Lessor and Lessee seek legal advice and obtain a written agreement in relation to the Lease, listing all mutually agreed clauses deemed necessary. The Society accepts no responsibility in relation to Lease arrangements and has limited powers to intervene. Disputes may be referred to arbitration by a neutral person or resolved through the Courts. Members may need to obtain legal representation to resolve disputes.

No Lease of a horse in the Society's records shall be effected unless the Lease Notification is signed by the Owner/Lessor and Lessee of the horse and form has been submitted to the Society and the prescribed fee pay. Leases will not be effected to Non-Members of the Society. Once the Lease has been effected, a copy of the Certificate of Registration which incorporates the Lessee details shall be supplied to the lessee. Once the Lease Termination has been effected, the Certificate of Registration which incorporates the Lease Termination details shall be supplied to the Owner/Lessor.

The Society recommends that the Owner/Lessor and the Lessee retain a copy of this document.
