# REGISTRATION FEES

Valid until 31<sup>st</sup> December 2024.

**Southern Hemisphere** - age is determined on 1<sup>st</sup> August and under 1 year rates apply until 15<sup>th</sup> September.

**Northern Hemisphere** - age is determined on 1<sup>st</sup> January.

## STUD BOOK & SECOND CROSS

### Mares & Stallions

Under 1 year .....	\$95
1 year & under 3 years .....	\$150
3 years & under 6 years .....	\$200
6 years & over .....	\$325
<b>Geldings</b> – any age .....	\$95
Stallion owner <b>UNFINANCIAL</b> when mare is served – penalty fee for registration of resulting progeny .....	\$50

## FIRST CROSS

Mares and geldings **ONLY**, stallions **NOT ELIGIBLE**.

Inspected by Society Inspector (any age) if branded or microchipped.

<b>Fillies</b> – under 4 years (incl. DNA & Genetic testing) .....	\$360
<b>Mares</b> – 4 years & over (incl. DNA & Genetic testing) .....	\$410
<b>Geldings</b> – any age (DNA testing not included) .....	\$180

## BASE REGISTRY

Fees include DNA & Genetic testing.

Inspected by Society Inspector (any age) if branded or microchipped.

<b>Fillies</b> – under 4 years .....	\$360
<b>Mares</b> – 4 years & over .....	\$410
<b>Geldings</b> – any age .....	\$275
<b>Until 1<sup>st</sup> Jan 2025, Colts</b> – under 4yrs (excludes Sire Rego) .....	\$550
<b>Until 1<sup>st</sup> Jan 2025, Stallions</b> – 4yrs & over (incl Sire Rego) ..	\$1,250

Applications received prior to 1st January 2025 must be fully completed (incl DNA testing) and a Certificate of Registration issued no later than 31st March 2025. **From 1<sup>st</sup> Jan 2025, the following fees will apply:**

## BREEDING PURPOSES ONLY

Horses registered in a Non Thoroughbred Register (or similar) are not eligible. NOT eligible for ASH events, 2<sup>nd</sup> Cross Breeding status ONLY. Inspected by Society Inspector (any age) if branded or microchipped.

<b>Mares &amp; Fillies</b> .....	\$400
<b>Stallions &amp; Colts</b> .....	\$1,050

**6 panel GDT:** OLWS, HYPP, HERDA, PSSM1, MH, GBED.

**1 panel GDT:** HERDA

Horses with a carrier parent must be DNA & GDT Tested.

<b>6 panel GDT only – Stallions already Sire Registered</b>	
Previously DNA Profiled with ASHS .....	\$130
If required, 2 <sup>nd</sup> sample - insufficient hair .....	\$65
<b>DNA Profile, plus 1 panel GDT – Mares</b> .....	\$140

One horse or embryo, single membership as new owner	
<b>Bulk Transfer Fee</b> .....	\$210

One horse or embryo, new owner under 18 years of age	
<b>Bulk Youth Transfer Fee</b> .....	\$150
