

REGISTRATION FEES

Applicable from 1st July 2025

Compulsory DNA – NEW applications from 1st October 2025

Southern Hemisphere – age is determined on **1st August**. **Northern Hemisphere** – age is determined on **1st January**.

Applications for ALL horses submitted prior to 1st October must be completed and Certificate issued by 15th January 2026.

For ALL Stud Book, Second Cross registrations and First Cross (with sire ASH), the sire's registration must be compliant with sire rules.

When the owner of horse being registered and the Registered Owner of ASH dam are different, a transfer fee will apply.

For samples received from 1st July 2025, 6 panel Genetic Disorder Tests will include: OLWS, HYPP, HERDA, PSSM1, GBED, MYHM.
