SPECIAL SERVICES AWARD Recipient/s will be presented at the ASHS Annual General Meeting

Description: The Special Services Awards are to recognise individuals that have contributed to their Branch, the Australian Stock Horse breed and/or the Society over a number of years. The award can also be awarded to Members who have contributed through extraordinary single efforts.

Prizes: The winners of the Special Services Award will receive a certificate with a special pin.

Nomination Procedure: I understand that these awards are not necessarily awarded annually and that there is no limit to the number of awards given. Nominations may be made by any Australian Stock Horse Society Member and must be endorsed by a Branch or State Management Council. Nominations for the Australian Stock Horse Society Special Services Awards are due **no later than 4.30pm Wednesday, 25th February 2026**.

On a separate sheet, outline why the nominee deserves this award. The Award may be given to individuals who have worked over a long period or contributed through a number of extraordinary single efforts for the Society and its promotion.

The ASHS Special Services Nominee must be a current financial Member of the Society and must be over 18 years of age.
